# About this freeware software license agreement

This software license agreement, hereinafter referred to as "freeware software license agreement" for software solutions, hereinafter referred to as "software", that can be downloaded from the Dr.Chgman.com website, hereinafter referred to as "Dr.Chgman.com", is a legal agreement between you (either on behalf of yourself as an individual or on behalf of an entity as its authorized representative), hereinafter referred to as "you", and AbitMORE byba, hereinafter referred to as "AbitMORE". This freeware software license agreement supersedes any previous versions.

By accepting this freeware software license agreement, downloading the software, installing the software, copying the software or otherwise using the software you agree to be bound by all of the terms of this freeware software license agreement regarding your use of the software. If you do not agree to the terms of this freeware software license agreement, do not accept this freeware software license agreement and/or do not download, install, copy or otherwise use the software.

#### **Grant of license**

#### **Title**

You agree that no title to the intellectual property in the software is transferred to you. Title, ownership, rights, and intellectual property rights in and to the software shall remain in AbitMORE.

Copyright and patent laws of Belgium and international treaties protect the software.

# **Updates**
